LICENSE GRANT

Upon confirmation of payment, the client is granted a **non-exclusive, non-transferable, perpetual, limited license** subject to the following conditions:

Usage Rights

The client may use 3D Garden Plants products in personal or commercial projects **without limitation on the number of projects**. This includes:

- ◆ **Rendered Media:** Using the models to create 2D rendered formats (e.g., images, videos, films, architectural visualizations).
- ◆ **Compiled Interactive Projects (Games/VR):** Using the models in compiled video games, VR/AR experiences, or interactive applications. **Condition:** The assets must be baked, compiled, or packaged in a way that the raw 3D meshes and textures cannot be directly accessed, extracted, or downloaded by the end-user.

License Types

Please select the appropriate license based on your entity's **total gross revenue and/or funding in the past 12 months prior to the date of purchase**.

- ◆ **Personal License:** For individual creators, freelancers, and small teams with gross revenue and/or funding of **less than \$100,000 USD**. This allows full commercial use for **unlimited users within the qualifying entity**.
